Meanwhile, the Hirslanden Clinique Cecil has core competencies in the specialty areas of cardiology, radiology, cardiovascular surgery, oncology, abdominal surgery, general surgery, gynaecology, obstetrics, urology, neurosurgery and internal medicine. It also runs an intensive care unit recognised by the Swiss Society of Intensive Care Medicine and a general emergency centre that is open 24 hours a day.
