# MANAGEMENT CHANGE AT HIRSLANDEN BERN

Daniel Lüscher, Hospital Manager of Klinik Beau-Site, Salem-Spital and Klinik Permanence, has decided to hand over the management of the three Hirslanden hospitals in Bern and accept a new challenge outside the Hirslanden Group. He will take over as Chairman of the Board of Directors of the Aarau Cantonal Hospital on 1 July 2023.

Daniel Lüscher joined the Hirslanden Group on 1 March 2020. First as Hospital Manager of the Hirslanden Campus Bern, which includes Klinik Beau-Site and Salem-Spital, and from 1 April 2022 additionally as Hospital Manager of Klinik Permanence. With the integration of the three Hirslanden hospitals in Bern under his leadership, the range of services offered by the hospitals was coordinated in an even more targeted manner and the existing synergies between the hospitals were utilised even more capably thanks to the lean management structure and the effective and efficient leadership of Daniel Lüscher.

#### Integrated care network

Daniel Lüscher consistently drove forward the expansion of a comprehensive medical network in Bern, with a clear focus on excellent integrated care, covering both primary care services and treatment in medical specialties as well as in the area of highly specialised medicine. This network was completed in May last year with the opening of the outpatient surgical centre "OPERA Bern". As part of the "continuum of care", this is fully in keeping with Hirslanden's corporate strategy of establishing and expanding regional integrated healthcare networks that are individually tailored to people: from prevention to aftercare, from birth to old age, outpatient and inpatient – at any time, in person and digitally.

Stéphan Studer, Chief Operating Officer of the Hirslanden Group, had this to say: "I very much regret the departure of Daniel Lüscher and thank him sincerely for his outstanding achievements in the service of Hirslanden. Daniel Lüscher has developed enormously at Hirslanden, which is recognised and appreciated both internally and externally. I am therefore very pleased for him that he will be taking on an extremely responsible and challenging position in the Swiss healthcare system in the future."

Daniel Lüscher will take over as Chairman of the Board of Directors of the Aarau Cantonal Hospital on 1 July 2023. Until his successor as Hospital Manager of the three Hirslanden hospitals in Bern has been appointed, he will continue to manage them on a part-time basis until the end of November 2023 at the latest.

The patient mix consisted of 51.7% patients with basic insurance, 27.5% with semi-private insurance and 20.8% with private insurance. The Hirslanden Group was formed in 1990 through the merger of several hospitals. Since 2007, it has been part of the international hospital group Mediclinic International.
